Tropical Activity Atlantic – Disturbance 1

- A tropical wave located over the eastern tropical Atlantic continues to produce a large area of disorganized showers and thunderstorms.
- Environmental conditions appear conducive for development of this system over the next few days, and a tropical depression could form during the early to middle part of next week while it moves westward at around 15 mph over the tropical Atlantic and approaches the Windward Islands.
- Formation chance through 48 hours...low...20 percent.
- Formation chance through 5 days...medium...60 percent.

Severe Weather Outlook

- AccuWeather meteorologists warn that there will be multiple days where severe weather will largely occur overnight, elevating the threat even more as many residents will be sleeping when storms are expected to roll through the region.
- The Upper Midwest and northern Plains have been able to enjoy comfortable and dry conditions over the past couple of days since the last round of severe storms rolled through the area on Monday.



SEVERE T-STORMS

- From North Dakota to Minnesota and into Nebraska, there were over 170 damaging wind reports, almost 40 reports of hail and three tornado reports.
- "The northern Plains and Upper Midwest will once again face a threat of severe weather on Friday where residents around Fargo, North Dakota, and Aberdeen, South Dakota, could deal with a round of potentially damaging thunderstorms," AccuWeather Meteorologist Brandon Buckingham said.
- By Friday afternoon, the threat of severe storms is expected to remain in this same region of the country from northern Minnesota to southern Nebraska. Storms are anticipated to be more organized in this part of the central U.S.
- Any strong storm on Friday afternoon through Friday night could feature large hail, wind gusts potentially nearing the AccuWeather Local StormMax[™] of 90 mph and even a few isolated tornadoes.

Declaration Request

Montana

- The state of Montana is requesting help from the • Federal Emergency Management Agency for individuals facing substantial losses from the flooding that's devastated parts of south-central Montana.
- The request, signed by Gov. Greg Gianforte on Wednesday, seeks to activate FEMA's Individual Assistance Program, which is part of the presidential major disaster declaration issued by the Biden Administration last week.



- The letter to FEMA said that a preliminary evaluation shows there were 23 majorly damaged or destroyed residences in Carbon County, 53 in Park and 39 in Stillwater. The letter estimates that 115 primary residences were either majorly damaged or destroyed, "with some completely washed away," according to preliminary data.
- In a Wednesday interview, state Insurance Commissioner Troy Downing said the numbers of people who had flood insurance in those areas was "horrible."
- There were just 18 policies in Red Lodge before flooding hit and another 58 across unincorporated Carbon County. There were only nine policies in Livingston and 77 in the unincorporated parts of Park County. And in Columbus there were just two policies.
