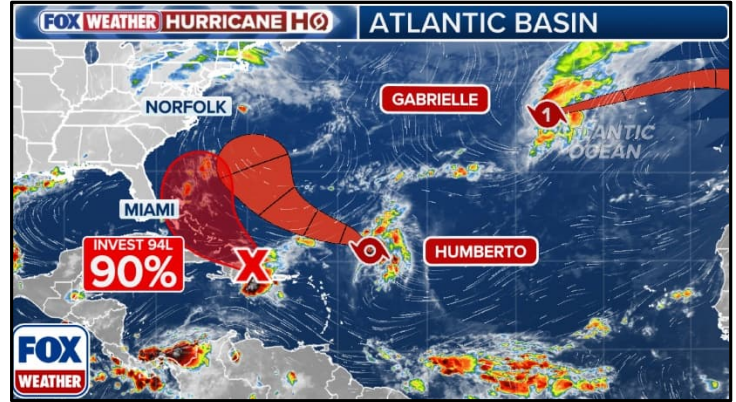

Tropical Activity

Atlantic – Tropical Storm Humberto

- Tropical Storm Humberto is continuing to become better organized as it spins across the Atlantic.
- Forecasters say it will likely strengthen into a major hurricane (Category 3 or higher) in the coming days.
- Maximum sustained winds of 45 mph with some higher gusts.
- By the start of next week, forecasters say Humberto could reach major hurricane strength with winds of at least 115 mph.
- Currently located about 480 miles to the east-northeast of the northern Leeward Islands and is moving off to the northwest at 10 mph.
- Expected to make a turn to the west-northwest or northwest over the next several days with a slower forward speed.



Atlantic – Disturbance 1 (94L)

- The National Hurricane Center (NHC) is continuing to monitor the development of Invest 94L in the Atlantic as forecasters now say there's a high chance it will become tropical depression or Tropical Storm Imelda in the coming days.
- According to the FOX Forecast Center, it could potentially have impacts on the U.S. East Coast.
- Invest 94L is near the Dominican Republic and is continuing to produce a large area of disorganized showers and thunderstorms, as well as gusty winds, across much of the island of Hispaniola and Puerto Rico.
- The system is expected to slow down and turn to the northwest when it reaches the southwestern Atlantic in a few days.
- Formation chance through 48-hour: High (70%); 7 day: High (90%)
