

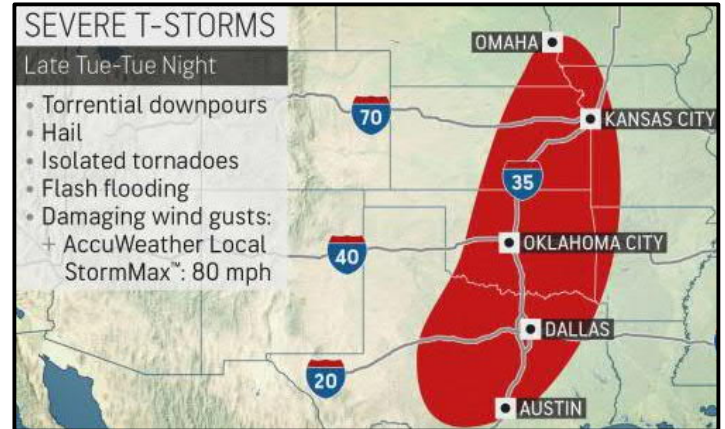

March 28, 2022

Severe Weather Outlook

- AccuWeather forecasters say the atmosphere over the southern United States is set to become primed for explosive weather in the days ahead.
- Residents in portions of the South still reeling from last week's bout of destructive weather may find themselves in the path of Mother Nature's wrath once again this week.
- The storm that is ultimately forecast to touch off potentially destructive weather across portions of the Central and Eastern states will first bring much-needed rain to the Southwest at the start of the week.
- Once this storm reaches the Plains, potent weather will be off to the races.
- Tuesday evening through Tuesday night, the threat for severe weather will center over a swath of the central United States from central Texas, north to far southeastern Nebraska and east into portions of Missouri and Arkansas.
- While hail and damaging wind gusts with an AccuWeather Local StormMax™ of 80 mph will be the main threats with any feisty storm into Tuesday night, a few tornadoes cannot be ruled out.
- Portions of central and northern Texas, as well as Oklahoma and Kansas, can be in the bull's-eye of the isolated tornado risk.
- In addition, torrential downpours are possible with the bulk of the thunderstorms. This heavy rainfall may trigger flash flooding, especially for low-lying and urban areas.



Tornado Activity (March 21-23, 2022)

Texas

- Damage assessments are currently on going through out the regions that were affected by the tornadoes and high winds that went through the state on March 21.
- To date, a total of nine (9) EF-0 tornadoes, 15 EF-1 tornadoes, eight (8) EF-2 tornadoes and one (1) EF-3 tornadoes have been confirmed in Texas by the National Weather Service bringing the total to 33.
- There are two more sites that have yet to be confirmed.
- On March 22, 2022, Governor Abbott issued a disaster declaration for the following counties: Bastrop, Cass, Cooke, Grayson, Guadalupe, Houston, Jack, Madison, Marion, Montague, Nacogdoches, Panola, Rusk, Upshur, Williamson, and Wise.
- Cooke County - four homes destroyed and one business with major damage.
- Grayson County - Of the 109 properties assessed, 53 were determined to be destroyed, 27 had major damage, nine had minor damage and 20 were unaffected.
- Madison County - Individual Assistance damage assessments are ongoing. Current numbers for homes: 9 Major, 20 minor, and 8 businesses.

- Houston County - Approximately 15 homes were destroyed, 22 sustained major damage, 17 minimum damage, and 13 were affected by the severe weather.
- Nacogdoches County - Approximately 22 homes were destroyed, 55 sustained major damage, 34 minimum damage, and 24 were affected by the severe weather.
- Travis County - Damage assessments are ongoing in the City of Elgin. Approximately 65 homes were damaged by the tornado in upper Elgin.

Louisiana

- Gov. John Bel Edwards has issued a state emergency declaration in response to the two tornadoes that ripped through St. Bernard Parish and other parts of metro New Orleans last Tuesday night.
- But as Edwards toured the devastation wrought in Arabi, he warned that the damage sustained may not be sufficient to trigger a federal disaster declaration that would pave the way for an influx of disaster aid.
- Preliminary damage assessments continue, but in a press conference shortly after noon on Wednesday, Edwards said at least 600 structures were reported damaged.
- According to the National Weather Service, at least two tornadoes touched down in southeast Louisiana, including a severe EF3 class tornado with 136-165 mph winds.
- United States Senator Bill Cassidy surveyed tornado damage in Arabi Thursday. Cassidy toured the devastated area with St. Bernard Parish officials.

Mississippi

- The Mississippi Emergency Management Agency is working to validate damage assessments following severe weather on March 22, 2022.
- At the time of this release, the National Weather Service Jackson has confirmed 11 tornadoes that swept across the state.
- Three injuries were reported to MEMA due to the storms (Clay, Copiah, and Holmes).
- The following damage numbers are preliminary and are subject to change throughout the assessment and validation process.
- We have reports from 14 counties that 224 homes have sustained some type of damage.
- At this time, 22 are classified as destroyed, and 34 are considered to have major damage in Attala, Clay, Hinds, Holmes, Kemper and Warren counties.
