
Wildfire Activity California

- A fast-moving wildfire burning on and around Camp Pendleton military base in Southern California forced thousands of people to flee in the early morning hours of Christmas Eve.
- The fire, dubbed the Creek Fire, broke out just after 11:00 p.m. local time. By 1 a.m. it had forced evacuations of housing areas on Camp Pendleton, a sprawling, 125,000-acre U.S. Marine Corps base between San Diego and Los Angeles.
- By 3 a.m., authorities with the San Diego A view of the Creek Fire, which was burning on and around Camp Pendleton, Sheriff's Department were forced to expand evacuation orders to include at least 7,000 people, most on the western side of Fallbrook, California, just outside of the military base.
- The fire has been fueled by Santa Ana winds, including gusts up to 35, and has now grown to at least 500-acres. It is currently uncontained. Winds were expected to continue through the afternoon before finally dying down by Thursday evening.

Declaration Request Colorado

- The members of Colorado's congressional delegation announced Wednesday that they wrote a letter asking President Donald Trump to issue a major disaster declaration for Colorado as the state recovers from a record-setting fire season.
- The letter was written in support of Gov. Jared Polis' initial request for a major disaster declaration, which would provide federal assistance to the state's fire recovery efforts.
- In its call for a major disaster declaration, the letter points to the three largest fires in Colorado's history, the Cameron Peak Fire, East Troublesome Fire and Pine Gulch Fire, which all burned in 2020.
- These fires and others forced thousands to evacuate across the state.
- 224 residential structures were destroyed and four sustained damage from the Cameron Peak fire in Larimer County. 42 of the residential structures impacted were primary residences.
- 366 residential structures were destroyed from the East Troublesome Fire in Grand County.
- The CalWood fire destroyed at least 26 homes in Boulder County.
