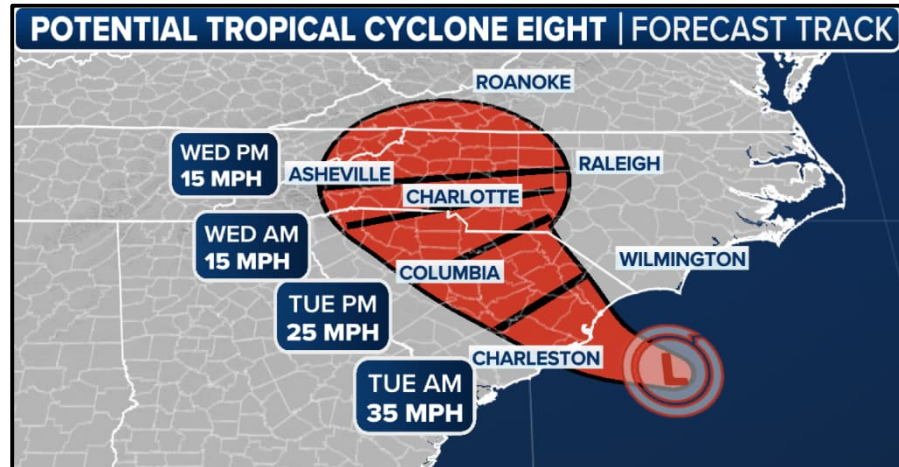

Tropical Activity

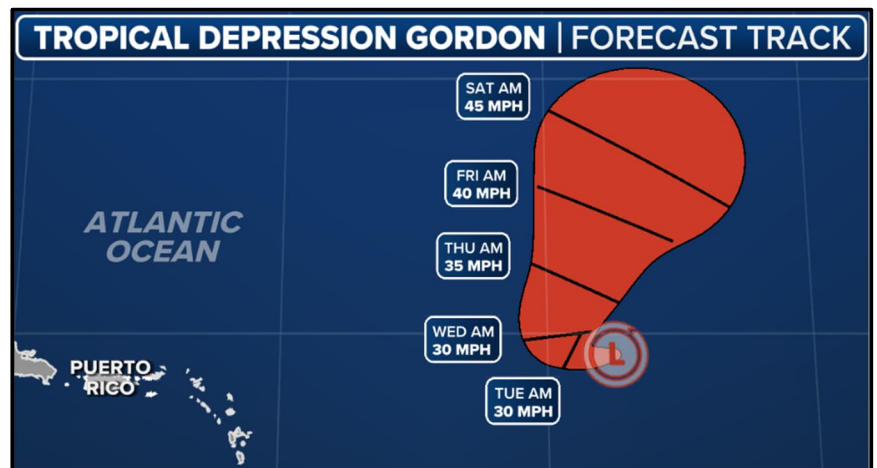
Potential Tropical Cyclone Eight

- Potential Tropical Cyclone Eight, expected to strengthen into Tropical Storm Helene early this week.
- Potential Tropical Cyclone Eight is located about 95 miles from Charleston, South Carolina.
- A Tropical Storm Warning is in effect for Edisto Beach, South Carolina northward to Ocracoke Inlet, North Carolina.
- Potential Tropical Cyclone Eight is likely to bring gusty winds, heavy rain with the potential for flash flooding, coastal flooding to portions of the Southeast and mid-Atlantic coasts over the next couple of days, the NHC warned.
- It could become a subtropical or tropical storm in the next day.
- Computer forecast models show a widespread swath of 4-8 inches of rainfall, with isolated totals near 10 inches across portions of northeast South Carolina into southeast North Carolina on Monday.
- Across the remainder of North Carolina, 2-4 inches of rainfall, with isolated totals near 6 inches, are expected through Tuesday.
- Over much of Virginia, 1 to 3 inches of rainfall, with locally higher amounts, are expected tonight through Wednesday.



Tropical Depression - Gordon

- Gordon is maintaining its status as a tropical depression on Monday after forming in the eastern Atlantic Ocean late last week.
- Wind shear and dry air, which are helping to hinder the tropical cyclone, will mask Gordon's future.
- As of the latest advisory from the National Hurricane Center (NHC), Tropical Depression Gordon was located about 1,000 miles east of the northern Leeward Islands.

- Its winds had decreased below the minimal tropical storm threshold (at least 40 mph).
- Gordon could become a post-tropical remnant low at any time, the NHC said.
- The NHC said Gordon will likely remain over open water for the next several days and poses no threat to any landmasses.
- It is currently moving west, and it's expected to continue on a west to west-southwest track over the next few days while slowing down considerably through midweek.
