
- Located over the south-central Gulf of Mexico

Ida Updates

Louisiana

- Nearly a week after Ida crashed into the Louisiana coast as a powerful Category 4 storm, President Joe Biden paid a visit to the state to tour the damage and visit with some of the survivors and officials who are working around the clock.
- On Friday, Biden addressed reporters in LaPlace, Louisiana. Because many people are still without phone and internet service, Biden said people representing the government and FEMA will go door to door to make sure impacted residents know what resources are available to them.
- The death toll continued to tick upward with at least 14 deaths being blamed on Ida in Louisiana, Mississippi and Alabama, according to The Associated Press.
- Mandatory evacuations for 9 parishes continue, voluntary evacuations for 11 parishes.
- More power has been restored to the New Orleans area and southeast Louisiana after Hurricane Ida caused widespread damage to the power grid.
- But more than 456,000 customers remain in the dark Monday morning. According to Entergy's website Saturday, Orleans Parish has more than 93,000 people without power, and 148,000 are waiting for their lights to come back on in Jefferson Parish.

Pennsylvania

- FEMA representatives will be in Bucks and Montgomery counties this week to start preliminary damage assessments to help determine what, if any, federal assistance may be available to areas hardest hit by the remnants of Hurricane Ida.
- FEMA will begin surveying damage in Montgomery County, as well as Philadelphia and Chester County, on Tuesday. FEMA will start its work in Bucks County on Wednesday.
- Before the storm, on Tuesday, Wolf signed a disaster emergency proclamation to allow the state to support the needs of communities that would be impacts and more quickly respond to requests for assistance for county officials throughout Pennsylvania.
- Wolf visited parts of Horsham and Upper Dublin, where a powerful EF2 tornado, created widespread, significant damage to homes, business and public building Wednesday. Three were killed in the storms.
- Horsham alone had 500 homes damaged, officials said.
- Montgomery County has already received more than 1,400 damage reports.

Declaration Request

New York

- Gov. Kathy Hochul provided an update Sunday on recovery efforts downstate as people there work to clean up after Ida.
- The Governor is requesting federal funding through FEMA's Individual Assistance Program for 14 Counties: Bronx, Dutchess, Kings, Nassau, New York, Orange, Putnam, Queens, Richmond, Rockland, Suffolk, Sullivan, Ulster and Westchester Counties.
- The state has incurred \$50 million in damages to public property and infrastructure, and at least 1,200 homes were damaged in the storms.
- 17 fatalities as a result of this storm.

Declaration Activity

DR-4614 New Jersey

- Residents of six hard-hit New Jersey counties hard hit by the remnants of Hurricane Ida will be eligible for federal assistance under a disaster declaration declared Sunday by President Joe Biden.
- Biden took action less than two days before he is scheduled to visit Manville on Tuesday, one of the areas hardest hit by last week's storms, which were blamed for the deaths of at least 27 people.
- Under the latest declaration, residents and business owners who suffered losses in Bergen, Gloucester, Hunterdon, Middlesex, Passaic and Somerset counties will be able to request assistance beginning Monday.
