Tropical Activity <u>Atlantic – Potential Tropical Cyclone Six</u>

- The disturbance is located about 535 miles south of Cameron, Louisiana, and is moving north-northwest.
- Forecast to organize into a tropical storm on Monday as it lifts northward.
- Strengthening into a hurricane is anticipated up until its landfall late Wednesday or early Thursday along either the far upper Texas coast or in southern Louisiana.
- After landfall, the system will spread rainfall through parts of the South to as far north as the mid-Mississippi and Ohio valleys.



- Tropical storm watches have been issued in Mexico from Barra del Tordo northward to the Mouth of the Rio Grande and in Texas from the Mouth of the Rio Grande to Port Mansfield.
- Hurricane, tropical storm and storm surge watches will likely be issued on Monday for portions of the upper Texas and Louisiana coastlines.
- Rainfall totals from the system could reach 4 to 8 inches, with local amounts to 12 inches, from the coast of far northeast Mexico to the far southern Texas coast and portions of southern Louisiana and southern Mississippi through Thursday morning.
- Life-threatening storm surge will build and inundate low-lying areas along the upper Texas and Louisiana coasts beginning Tuesday night.
- Much of the Texas coast will see gusty winds as the system lifts northward early this week. Localized power outages can't be ruled out in bands of rain that contain stronger gusts.
- The strongest winds will arrive at landfall and for some distance inland along the upper Texas and Louisiana coasts.
- An isolated tornado threat from this system could develop by Wednesday or Wednesday night in southern Louisiana, southern Mississippi, southern Alabama and the western Florida Panhandle.
- The tornado threat may persist along the northern Gulf Coast Thursday, while also spreading as far north as the Tennessee Valley by Friday.

<u> Atlantic – Disturbance 1</u>

- An area of low pressure is producing disorganized showers and thunderstorms over the central tropical Atlantic.
- Environmental conditions are marginally conducive for development during the next few days, and a tropical depression could form while the system meanders over the central tropical Atlantic.
- Formation chance through 48 hours Medium (60%); 7 days Medium (60%)



Atlantic - Disturbance 2

- A trough of low pressure located several hundred miles west-southwest of the Cabo Verde Islands is producing a broad area of disorganized showers and thunderstorms.
- In a couple of days, this trough is expected to interact with an approaching tropical wave.
- Afterward, environmental conditions appear favorable for gradual development of this system, and a tropical depression could form during the middle to latter part of this week while the system moves west northwestward at 10 to 15 mph.



• Formation chance through 48 hours – Low (near 0%); 7 days – Medium (60%)
