## Winter Storm Ember

- Winter Storm Ember will likely be the first snowstorm in quite a while for parts of the East.
- Dangerous travel conditions and some power outages are possible due to heavy snow, ice, rain and wind this weekend.
- Low pressure will intensify as it tracks from the Deep South northward up the East Coast this weekend. The storm could go on to become a nor'easter, which means it would have winds blowing from a northeast direction along parts of the Eastern Seaboard.



- The track of the low will allow the storm to produce snow, a mix of rain and snow and some ice in areas where its moisture interacts with colder air to the north and west of the low's track from the Ohio Valley into parts of the Appalachians, mid-Atlantic and Northeast Saturday and Saturday night.
- Some areas will experience gusty winds. The combination of heavy, wet snow and strong winds may lead to some power outages and tree damage, particularly from northeastern Pennsylvania into much of southern and central New England.
- Ember will begin to pull away from the Northeast by later Sunday, but snow, rain and wind will continue through the day.
