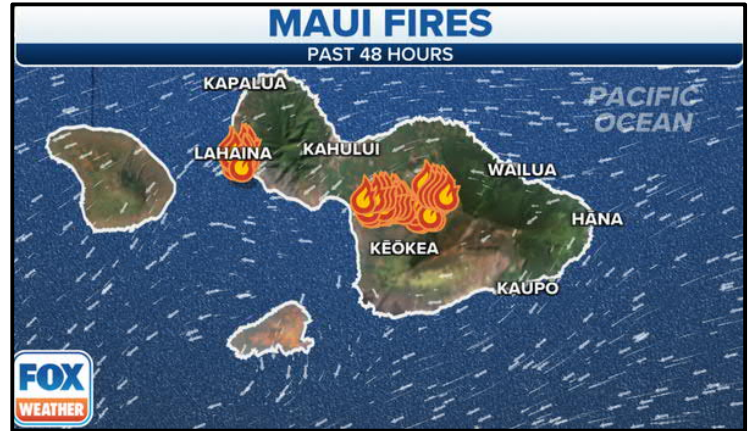

## Wildfire Activity

### Hawaii

- Three fires remain active on Maui in Lahaina, Pulehu and Upcountry, the County of Maui said in a 10:30 p.m. local time (4:30 a.m. EST) update.
- The Maui Fire Department reported “no significant changes” on the three fires, and there are no new evacuations. No containment estimates were available.
- At least 36 people have died, according to a statement from Maui County late on Wednesday (Thursday evening AEST) that said no other details were available.
- An estimated 11,000 people have fled the island of Maui in the wake of the wildfires, Hawaii Department of Transport director Ed Sniffen told NBC News. Another 2,000 people are expected to be evacuated today, the report added.
- Much of the western Maui community of Lahaina, where about 12,000 people live, is destroyed and hundreds of families there have been displaced, Hawaii Gov. Josh Green said. More than 270 structures have been impacted in Lahaina, county officials said.
- Cell service out for thousands in Maui and it could take days or even weeks to fix networks. Officials have been using satellite phones to communicate with providers on the west side of Maui to restore power to the area, Lt. Gov. Sylvia Luke said.
- More than 11,000 customers on Maui were without power as of 11 p.m. Wednesday local time (5 a.m. ET Thursday), according to PowerOutage.us, accounting for about 15% of the island’s customers.
- More than 2,100 people were in four emergency shelters in Maui on Tuesday night, the mayor’s office said.
