Severe Weather Outlook Central & East U.S.

- Ongoing storms from Monday night will continue moving across parts of the central U.S. early Tuesday morning.
- Storms will strengthen as they head into Ohio Valley.
- The FOX Forecast Center says the greatest threat from these storms will be damaging wind gusts and large hail, but an



isolated tornado cannot be ruled out.

- The northern half of this kind of general storm system, it's really encompassing places like Syracuse, Buffalo, Erie, Cleveland, all the way down to Louisville.
- There's also a second area of this massive threat zone where people need to keep an eye on the sky Tuesday.
- FOX Weather Meteorologist Britta Merwin said. "The southern part also has a bull's-eye, a 3out-of-5 potential here for severe weather. Part of the kicker here for Texas is going to be that potential for very large hail."
- Communities in this increased-risk zone include Wichita Falls, Abilene and Midland in Texas.

Joint Preliminary Damage Assessment Summary

Mississippi (Apr 2-6)

- The National Weather Service has confirmed that at least 14 tornadoes touched down in Mississippi between April 2nd and April 6th.
- This includes two EF-3 tornadoes located in Tate County and Marshall County, along with five EF-2 tornadoes, six EF-1 tornadoes, and one EF-0 tornado.
- MEMA has received reports of damage to 414 homes, 14 businesses, and 20 farms statewide. Of the homes affected, 54 were destroyed, while 68 sustained major damage.

Michigan (Mar 28)

- Beginning on March 28, 2025, and, in some areas, lasting through March 30, 2025, northern Michigan experienced impactful winter weather that resulted in extreme and severe ice accumulation that had significant impacts to critical services throughout the region. In particular, the region has suffered widespread power outages, including loss of backup generators; loss of phone and cellular services; and impassable roads due to downed trees and other debris.
- The Michigan State Police, Emergency Management and Homeland Security Division (MSP/EMHSD) partnered with FEMA and local officials to assess the impact of the storm.

• Preliminary damage assessments were performed in the following 12 counties: Alcona, Alpena, Antrim, Charlevoix, Cheboygan, Crawford, Emmet, Mackinac, Montmorency, Oscoda, Otsego and Presque Isle counties.

Missouri (Mar 30 & continuing)


- Missouri Governor Mike Kehoe requested joint preliminary damage assessments from the Federal Emergency Management Agency following severe storms and flooding that began on March 30.
- Joint assessments were requested for the following 20 counties: Bollinger, Butler, Cape Girardeau, Cooper, Carter, Dunklin, Howell, Iron, Mississippi, New Madrid, Oregon, Ozark, Reynolds, Ripley, Scott, Shannon, Stoddard, Vernon, Washington, and Wayne.
- Six teams consisting of representatives from FEMA, the State Emergency Management Agency, the U.S. Small Business Administration, and local emergency managers assessed the damage to determine whether Missouri meets the criteria to request Individual Assistance from FEMA.

Disaster Declaration Request Summary

<u>Oklahoma</u>

- More than 130 fires were reported across Oklahoma, forcing evacuations in several communities in areas near the fires.
- There have been four confirmed fatalities and 200 injuries.
- According to the Oklahoma Department of Emergency Management, the latest damage assessments show:
 - 9 homes damaged in Cleveland County
 - o 21 homes damaged in Oklahoma County
 - o 35 homes damaged in Lincoln County
 - o 70 homes damaged in Creek County
 - o 114 homes damaged in Logan County
 - o 115 homes damaged in Pawnee County
 - o 173 homes damaged in Payne County
- On March 21, Governor Kevin Stitt requested a Major Disaster Declaration from President Donald J. Trump for individual assistance for seven counties (Cleveland, Creek, Payne, Pawnee, Lincoln, Logan and Oklahoma) due to impacts from dangerous wildfires and straight-line winds that began Friday, March 14th.
- On April 2nd, WSP responded to a proposal request for this event. We are waiting for FEMA's decision award.



Mississippi


- Multiple counties experienced flooding, straight-line winds and tornadoes on March 14-15.
- Two tornadoes struck the same location in Covington County, Mississippi struck within 41 minutes of each other on March 15. The National Weather Service out of Jackson, Mississippi, noted that the first tornado was an EF-4 that originated out of Kentwood, Louisiana. The second twister originated north of Bassfield, Mississippi, and crossed the first tornado's path.
- The (NWS) confirmed that 18 tornadoes touched down on March 14 and 15 in Mississippi, including one EF-4, one EF-3, seven EF-2, seven EF-1, and two EF-0 tornadoes.
- FEMA-validated numbers show 233 homes were destroyed, 208 homes received major damage, 230 had minor damage and 92 homes were affected.



- On April 1, 2025, Mississippi Governor Tate Reeves requested a Major Disaster Declaration from President Trump for Individual Assistance and Public Assistance for counties impacted by the severe storms, flooding, straight-line winds, and tornadoes on March 14 – 15, 2025.
- The state requested individual assistance for 14 counties: Carroll, Covington, Grenada, Holmes, Issaquena, Itawamba, Jasper, Jefferson Davis, Leflore, Marion, Montgomery, Pike, Smith and Walthall.
- On April 10th, WSP responded to a proposal request for this event. We are waiting for FEMA's decision award.

Missouri

- The National Weather Service confirmed 112 tornadoes touched down in the U.S. from March 14-16.
- Of the 19 tornadoes in Missouri, 12 occurred in the southeast from Poplar Bluff to metro St. Louis.
- Missouri has reported 13 storm-related deaths, including six in hard-hit Wayne County and at least three in Ozark County.
- At the height of the storm, more than 140,000 homes and businesses were without power, and 101 roads were closed due to debris, flooding, and structural damage.
- On March 14th, Governor Mike Kehoe declared a state of emergency in Missouri in anticipation of severe weather forecasted throughout the state.



• On March 17th, Governor Kehoe requested that the Federal Emergency Management Agency (FEMA) participate in joint preliminary damage assessments (PDAs) for Individual Assistance in



23 counties following the severe storms and deadly tornadoes that devastated Missouri on March 14-15. On March 18th, the Governor expanded his request to add two additional counties, bringing the total to 25.

- Initial damage estimates indicate approximately 368 houses were destroyed, 356 sustained major damage and 1,058 suffered minor damage.
- On April 2, 2025, Governor Mike Kehoe requested that President Donald J. Trump approve a major disaster declaration to provide individual assistance for the following 25 counties: Bollinger, Butler, Camden, Carter, Dunklin, Franklin, Howell, Iron, Jefferson, Laclede, Madison, N ew Madrid, Oregon, Ozark, Pemiscot, Perry, Phelps, Pulaski, Reynolds, Ripley, St. Louis, Stoddard, Wayne, Webster, and Wright.
- On April 9th, WSP responded to a proposal request for this event. We are waiting for FEMA's decision award.

Texas

- From March 26–28, 2025, significant rainfall across South Texas led to destructive flooding throughout the Lower Rio Grande Valley.
- Rainfall of nearly 20 inches (measured) and potentially just over 21 inches (radar-estimated) pummeled much of the Rio Grande Valley, from eastern Starr County through southern Hidalgo County and into northern Cameron County.
- The floods forced evacuations in many communities, with portions of Cameron County and parts of Hidalgo County under mandatory evacuation orders, in addition to voluntary evacuations in other areas.
 First responders and volunteers carried out hundreds of water rescues, and as of April 4, 2025, over 30 search and rescue missions had been conducted.



- FEMA staff joined local and state partners in conducting Joint Preliminary Damage Assessments throughout the impacted counties virtually and in person. As of April 14, 2025, FEMA had confirmed the following damages: 842 affected, 2,618 minor, 1,911 major, and 235 destroyed.
- On April 17th, Governor Greg Abbott requested a Presidential Disaster Declaration for South Texas communities impacted by recent rainfall and flooding. The Governor's letter requests Individual Assistance for the counties of Cameron, Hidalgo, Starr, and Willacy.
- On April 25th, WSP responded to a proposal request for this event. We are waiting for FEMA's decision award.



Arkansas (Appeal)

- A powerful storm system resulted in a multi-day outbreak of severe storms across Arkansas beginning Friday, March 14, and continuing through Saturday, March 15.
- As of March 17, at least 3 fatalities and 32 injuries were reported across Arkansas.
- 10 of the tornadoes that have been confirmed were • rated EF-2 or stronger.
- 6 tornadoes had paths of 18 miles or longer.
- 3 tornadoes tracked 32, 45, and 117 miles, respec-• tively.
- The tornado, which struck the towns of Ash Flat and • Fifty-Six, is one of the longest tracks in state history, with a path length of 117 miles and a total time on the ground of 2 hours and 13 minutes.



- This tornado outbreak is the second largest since the tornado outbreak on April 25, 2011, • sitting behind the Memorial Day weekend outbreak of 2024.
- The number of EF-3+ tornadoes in this event is the highest since January 21, 1999.
- Joint local, State, and FEMA Individual Assistance damage assessments began on March 17, 2025, and concluded on March 20, 2025.
- After ground assessments, a review of geospatial data, and open-source data, there were 456 structures assessed with an average of 72.17% ownership and 66.77% insured:
 - o 156 categorized as destroyed
 - 93 categorized as major
 - 88 categorized as minor
 - o 119 categorized as affected
- On March 21, 2025, Governor Sarah Huckabee Sanders requested individual assistance for nine counties (Greene, Hot Spring, Independence, Izard, Jackson, Lawrence, Randolph, Sharp, and Stone).
- The State of Arkansas received a formal denial from the federal government for Individual Assis-٠ tance on March 14.
- On April 18, 2025, Governor Sanders appealed FEMA's decision to deny Arkansas' Major Disaster Declaration for Individual Assistance.
- On March 31st, WSP responded to a proposal request for this event. We are waiting for FEMA's decision award.

<u>Tennessee</u>

• From April 2–6, 2025, a slow-moving weather system and a stationary front caused widespread and devastating tornado outbreak and historic, life-threatening flash flooding across Tennessee.



- The National Weather Service confirmed that 19 tornadoes affected western and central Tennessee during the weather event.
- There were ten weather-related fatalities.
- In addition to the devastating outbreak of tornadoes, this event brought up to 15 inches of rain in some areas, causing severe flooding and flash flooding throughout the state.
- Straight-line winds with gusts up to 90 mph caused significant damage to property in multiple counties.
- On April 18, Tennessee Gov. Bill Lee formally requested a Major Disaster Declaration to make federal assistance available to the West and Middle Tennessee counties impacted by severe weather and flooding on April 2-6. The request follows completed damage assessments across impacted counties.
- The Major Disaster Declaration request comes in addition to the Emergency Declaration that was requested by Gov. Lee on April 2 and approved by President Donald J. Trump on April 3.
- Gov. Lee has requested Individual Assistance (IA) for the following 15 counties: Cheatham, Davidson, Dickson, Dyer, Grundy, Hardeman, Hickman, Humphreys, Lewis, McNairy, Montgomery, Obion, Perry, Sumner, and Wilson counties.
- On April 24th, WSP responded to a proposal request for this event. We are waiting for FEMA's decision award.
