
WSP USA INSPECTION SERVICES DISASTER AWARENESS REPORT

December 6, 2021

Severe Weather & Flood Activity Hawaii

- A strong Kona storm is pounding Hawaii with strong winds, flooding rain and, over some high-mountain peaks, blizzard conditions.
- Southerly winds induced by low pressure to the northwest of Hawaii are pumping moisture into the state, resulting in bands of heavy rain early this week.
- These bands may be slow-moving, capable of dumping rainfall rates over 1 inch per hour, which will quickly produce



flash flooding, especially in hilly or mountainous terrain. Landslides are also possible.

- The National Weather Service said in its flood watch that storm total rainfall amounts of 10 to 15 inches are expected through early this week, with localized totals over 20 inches possible. This could induce serious flooding in parts of the island chain.
- Flooding was reported on Maui Sunday night, including in some homes in the Maui Meadows subdivision. A reporting station on the island near Kula had picked up over 10 inches of rain in the 24 hours ending midnight, local time.
- Scattered thunderstorms could also occur in this Kona storm setup. A few of these storms could turn severe with large hail and strong wind gusts.
- The Kona low should finally pull far enough westward to end the heavy rain threat in most parts of the island chain by Wednesday.
- On Sunday evening, Hawaii County Mayor Mitch Roth signed a Severe Weather Condition First Emergency Proclamation, declaring a state of emergency for the County of Hawaii.

Washington

- Following a series of "atmospheric rivers" in November that delivered record-breaking rainfall totals in Whatcom County, officials are continuing to assess flood damages and begin work on recovery.
- As of Dec. 3, officials say damage to public infrastructure, businesses and private property has been estimated at approximately \$50 million.
- On Saturday, Representative Rick Larsen toured damaged areas in Whatcom County.
- Whatcom County authorities say 1,400 homes have been impacted by flooding. Of that number 500 have major damage and 60 are uninhabitable.
- Preliminary damage assessments are ongoing and support Whatcom County's request for aid from the state and federal governments.

DR-4614 New Jersey

- New Jersey residents recovering from Hurricane Ida have more time to apply for federal assistance.
- FEMA has extended its deadline from Monday, Dec. 6, to Wednesday, Jan. 5.

DR-4615 New York

- Some New Yorkers impacted by Hurricane Ida now have until January to apply for assistance from the federal government, FEMA announced Friday.
- Homeowners and renters with uninsured or underinsured damage to their property from Hurricane Ida have until Tuesday, Jan. 4, to apply for FEMA disaster assistance.
