

Tropical Activity Atlantic – Disturbance 1

- A surface trough of low pressure, associated with the remnants of Cindy, is producing disorganized showers and thunderstorms more than 500 miles to the southsoutheast of Bermuda.
- While strong upper-level winds are expected to prevent redevelopment of this system over the next day or two, environmental conditions could then become a little more favorable for some gradual redevelopment during the latter part of this week.
- This system should move generally northward into the northwestern Atlantic Ocean, passing near Bermuda on Thursday.
- Formation chance 48 hours: Low (near 0%); 7 days: Low (30%)

Severe Weather Outlook


- Dangerous weather is forecast to sweep through the East Coast, with some areas of the Northeast expected to be at risk for severe weather for multiple days.
- "An influx of moisture from the South will be a key factor behind the train of severe storms marching into the East Coast on Monday," said AccuWeather Meteorologist Alyssa Smithmyer.
- The excessive moisture present will help to make severe weather possible across a wide swath of the East Coast into Monday night.



- The most widespread severe risk other than cloud-to-ground lightning is expected to be damaging winds, with gusts of 60-70 mph possible. Storms may also contain hail and a few isolated tornadoes, all of which could cause power outages, tree damage and travel disruptions.
- Thunderstorms are forecast to rumble from central New York and southern New England to Alabama and Georgia, including cities like Pittsburgh, Pennsylvania, New York City, Raleigh, North Carolina, and Atlanta. The Washington, D.C. area is forecast to have a higher risk for these storms.
- As the week progresses, thunderstorms could once again be feisty on Tuesday, which will again threaten some of the same cities, like Philadelphia.

Severe Weather Activity

<u>Indiana</u>

- At least one person died and another was injured after severe weather rampaged across the central United States on Sunday.
- According to the National Weather Service's Storm Prediction Center, there were more than 400 severe weather reports on Sunday, and the bulk of those were wind or hail damage.
- Dozens of homes were damaged and thousands remained without power as of Monday morning.
- Martin County Emergency Management employee Monty Wolf confirmed to The New York Times that at least one person had died and another was injured after a tornado struck their home in Martin County on Sunday. Martin County is located roughly 105 miles south of Indianapolis.
- Just outside of Indianapolis in Johnson County, Indiana, a large and violent tornado was spotted destroying several homes.
- Officials in Bagersville, -- located in Johnson County -- said 75 homes have moderate to severe damage, according to FOX 59 News.
- In southern Indiana, a confirmed tornado was reported in Crane at around 3:33 p.m. CDT by law enforcement.
