

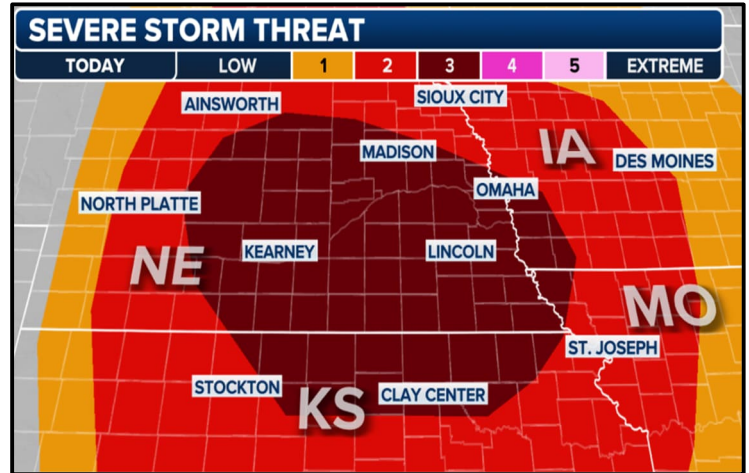

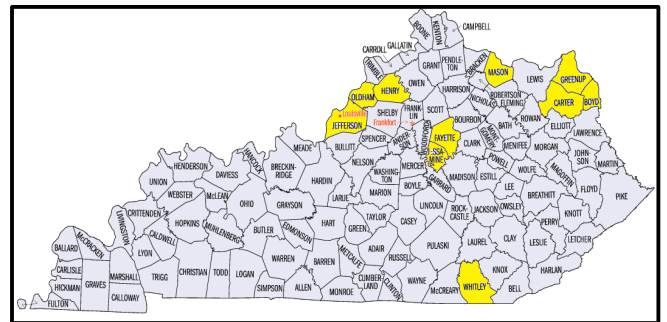
Severe Weather Outlook

- It's been a relentless stretch of severe weather, especially in the central part of the country.
- Wednesday was no different, with severe weather and a likely tornado causing damage in Temple, Texas.
- This will continue Thursday with tornadoes, large hail and damaging winds possible in a swath that stretches from North Dakota to Mississippi.
- The worst of the storms is expected in parts of Nebraska and Kansas.
- The FOX Forecast Center said an area of enhanced wind likelihood is most likely to develop across the Central Plains during Wednesday evening.
- Severe storms will remain rather scattered across the southern Plains through the Mid-South but could become quite strong during the afternoon and evening hours, the FOX Forecast Center said.
- Wichita, Kansas, Oklahoma City and Dallas are among the major cities that may encounter this significant weather event.



Disaster Declaration Activity Kentucky

- On May 22 President Joseph R. Biden, Jr. declared that a major disaster exists in the Commonwealth of Kentucky and ordered Federal assistance to supplement Commonwealth and local recovery efforts in the areas affected by severe storms, straight-line winds, tornadoes, landslides, and mudslides on April 2, 2024.
- The President's action makes Federal funding available to affected individuals in the counties of Boyd, Carter, Fayette, Greenup, Henry, Jefferson, Jessamine, Mason, Oldham, Union, and Whitley.
- The Governor said additional counties could be added after additional damage assessments are completed.
- In addition to the severe wind, thunderstorms, mudslides, and flooding that hit the Commonwealth, more than a dozen tornadoes swept through Kentucky.
- At the height of the storm's impact, more than 32,000 Kentuckians were without power.



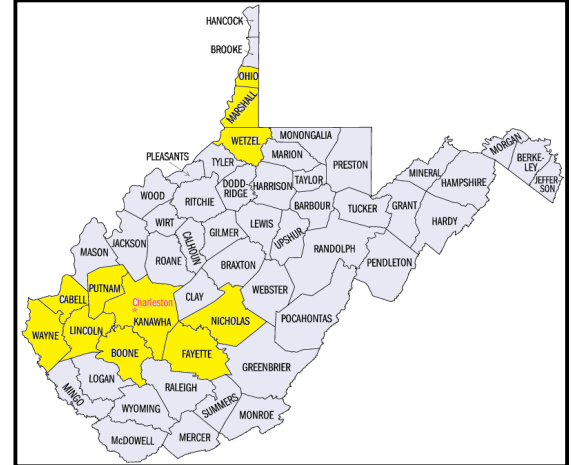

West Virginia

- On May 22, President Joseph R. Biden, Jr. declared that a major disaster exists in the State of West Virginia in the areas affected by severe storms, straight-line winds, tornadoes, flooding, landslides, and mudslides from April 2 to April 6, 2024.
- The President's action makes Federal funding available to affected individuals in the counties of Boone, Cabell, Fayette, Kanawha, Lincoln, Marshall, Nicholas, Ohio, Putnam, Wayne, and Wetzel.
- A major storm system slammed the region damaging homes, toppling trees and causing widespread power outages.
- The National Weather Service reported winds in excess of 90 miles an hour at the Huntington airport and widespread wind damages from Huntington all the way into downtown Charleston.
