Tropical Activity

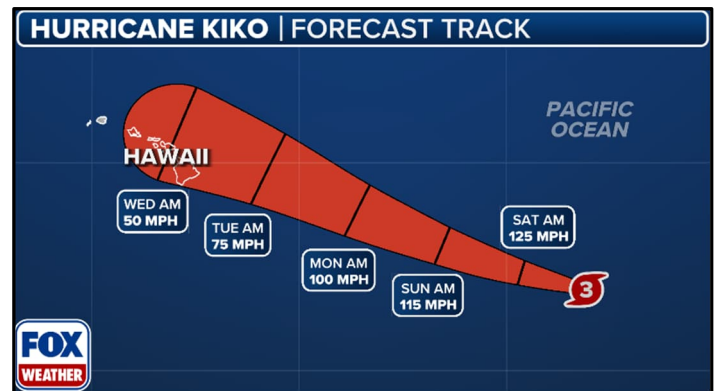
Atlantic – Invest 91L

- The National Hurricane Center (NHC) designated a tropical disturbance that emerged off the coast of Africa last week-end as Invest 91L on Thursday.
- Forecasters are saying it will likely become Tropical Depression Seven by the end of the weekend.
- Currently located in the eastern tropical Atlantic and is producing what the NHC said Friday was "a concentrated but disorganized area of showers and thunderstorms."
- The disturbance is now in an area where environmental conditions remain conducive for tropical development.
- FOX Forecast Center said that the steering currents are weak across the tropical belt, so it may take about a week until the system is in the vicinity of the Caribbean islands.



Eastern Pacific – Hurricane Kiko (CAT 3)

- Located over 1,300 miles east-southeast of Hilo, Hawaii moving at 9 mph, and expected to commence a significant weakening process over the weekend.
- Meteorologists said that Kiko will be a completely different storm by the time it approaches Hawaii early next week.
- Kiko has hurricane-force winds only extending outward 20–30 miles and tropical-storm-force winds extending outward up to 80 miles.
- Rough seas and occasional showers look to be nearly a guarantee, with the possibility of increasing impacts if the cyclone were to take a more southern route.
