# Tropical Activity Atlantic - Disturbance 1

- The National Hurricane Center has determined that Gordon is no longer a tropical depression, after degrading since the overnight hours.
- Environmental conditions could become more conducive for development later this week, and a tropical depression or storm could re-form in a few days while the system moves slowly northward over the central subtropical Atlantic.
- Formation chance through 48 hours...low...30 percent.
- Formation chance through 7 days...medium...60 percent.


# All Disturbances

### Gulf of Mexico - Disturbance 2

- Located in the northwestern Caribbean Sea.
- There are increasing signs of atmospheric conditions favorable for the development of possibly the next named storm sometime next week.
- Formation chance through 48 hours...low...0 percent.
- Formation chance through 7 days...low...20 percent.

# Disaster Declaration Request South Carolina

- South Carolina Gov. Henry McMaster applied for federal disaster aid to help homeowners in Lowcountry counties impacted by Tropical Storm Debby last month.
- The storm, which made landfall in South Carolina on Aug. 8, damaged more than 900 homes in Charleston, Colleton and Dorchester counties, Derrec Becker, spokesman for the state Emergency Management Division, told the SC Daily Gazette on Tuesday.
- Among those homes counted by county and state officials, issues ranged from minor damage to shingles to total destruction, he said.
- struction, he said.
  The Presidential Disaster Declaration would allow for direct aid to homeowners in Charleston, Colleton and Dorchester counties.
- In those three counties, 84 residences had major damage, three were destroyed and drinking water from wells at 100 Charleston County homes was contaminated, according to damage estimates provided to the governor.
