## Severe Weather Outlook

- Severe weather has already begun impacting Oklahoma, Arkansas and Missouri on Monday night as tornadoes, hail and gusty winds were all reported.
- Another explosion of severe weather is anticipated from Tuesday afternoon to Tuesday night from eastern Texas and much of Louisiana, northward to southern Minnesota and part of southwestern Wisconsin.
- Violent thunderstorms are most likely to develop over two parts of the Central states on Tuesday.



- "One area where thunderstorms are likely to focus will be over the central Plains, in conjunction with the main storm system set to emerge from the Rockies, while a second contracted area of thunderstorms will focus across the southern Plains, in association with wind energy from the jet stream," AccuWeather Meteorologist Andrew Johnson-Levine said.
- The northern higher-risk zone will include western and central lowa, southeastern Nebraska, northeastern Kansas and northwestern Missouri.
- The southern primary threat area will include northeastern Texas and southeastern Oklahoma as well as parts of southwestern Arkansas and northwestern Louisiana.
- The threat of severe thunderstorms and tornadoes may continue through the nighttime hours on Tuesday.

## March 2022 Tornado Activity

- Last month broke the record for the most tornadoes on record for the month of March according to the National Weather Service (NWS).
- The agency's Storm Prediction Center (SPC) reports March 2022 recorded 218 tornadoes in the United States, breaking the previous record of 192 in 2017.
- NWS adds 2022 is the 4th-straight year with at least one violent tornado, and EF4 or above in the month of March,

- There were also 5 days with 3 or more EF2 or stronger tornadoes, including the days of March 5,21,22,30, and 31. March also had 41 tornado watches issued, tying for the 8th-most on record for the month.


