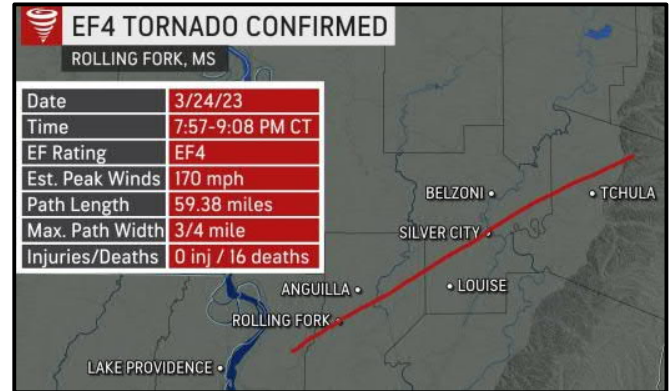

Tornado Activity

Mississippi

- The Mississippi Emergency Management Agency continues to assess the damage in multiple counties affected by the March 24th tornadoes and severe weather.
- As of March 28th, the National Weather Service has confirmed seven tornadoes touched down in Mississippi. One EF-4 tornado (Rolling Fork/Silver City tornado), two EF-3 tornadoes (Carroll/Montgomery County tornado and Monroe County tornado), and four EF-1 tornadoes impacted the state.
- Residents in Carroll, Humphreys, Monroe and Sharkey Counties can apply for individual assistance.
- Preliminary damage assessments (counties reporting some damage to homes ranging from affected to destroyed):
 - Carroll County – 24 homes
 - Humphreys County – 55 homes
 - Monroe County – 1,476 homes
 - Sharkey County – 255 homes



Declaration Request

California

- Tuesday, March 28th, Governor Newsom requested a Presidential Major Disaster Declaration to help bolster emergency response in the state.
- The conditions in California continued to deteriorate due to the Winter Storms and ongoing Atmospheric River events that commenced February 21, 2023 and continues to overwhelm California through March.
- He is requesting all Individual Assistance programs for the following counties: Kern, Mariposa, Monterey, San Benito, Santa Cruz, Tulare, and Tuolumne.
- In most counties harmed by the Late Winter Storms event, only 5 percent of residents have flood insurance. Furthermore, of the subject counties, at least 30 percent of the population lacks homeowners or personal property insurance
- According to initial Joint-PDAs conducted with FEMA, 42 homes and businesses have been destroyed, 378 have suffered major damage, 171 have suffered minor damage, and 87 have been affected by heavy flooding.

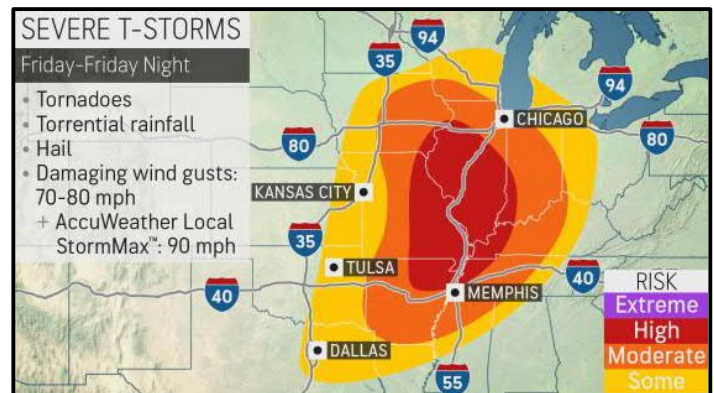

- However, these Joint-PDAs are currently ongoing and do not show the entirety of all IA damages in the numbers provided.
 - Monterey County – 200 homes have suffered major damage or have been destroyed.
 - San Benito County – 6 homes have been destroyed, 31 have suffered major damage, 20 have suffered minor damage and 5 more affected.
 - Santa Cruz County – 7 destroyed homes and businesses, 26 suffered major damages, 10 minor and 5 affected.
 - Kern County – 10 homes destroyed, 16 with major damage, 61 with minor damage and another 29 affected.
 - Tulare County – 2 homes have been destroyed, 101 with major damage, 52 with minor damage and another 21 have been affected.
 - Mariposa County – 12 homes destroyed, 12 have major damage, 15 with minor damage and another 4 affected.
 - Tuolumne County – 11 homes and businesses destroyed, 16 suffered major damage, 10 minor damage and 11 have been affected.

Severe Weather Outlook

- The severe weather threat will reach well to the north over the central United States by Friday and bring the risk of tornadoes.
- The first thunderstorms associated with the system will likely erupt over Nebraska and northern Kansas Thursday evening and persist into the night.
- The main threats from the storms on Thursday evening will be hail and high winds with the potential for a couple of tornadoes.
- Friday will be the prime day for severe weather and is likely to encompass more than a dozen states in the middle of the nation. The current risk extends from central Texas northward by nearly 1,000 miles to southern Wisconsin.
- "The threat of severe weather that includes the potential for some tornado activity includes the Chicago area and could extend well to the north in Wisconsin," AccuWeather Meteorologist Matt Benz said.
- On Friday, all modes of severe weather will be possible, ranging from large hail and tornadoes to strong wind gusts, frequent lightning strikes and flash flooding.
- "This severe weather outbreak will bring a widespread threat of damaging winds and is highly likely to produce a number of tornadoes," AccuWeather Chief On-Air Meteorologist Bernie Rayno said.
- The risk of severe weather from Friday-to-Friday night includes parts of northern Mississippi that were hit by tornadoes last Friday evening.
