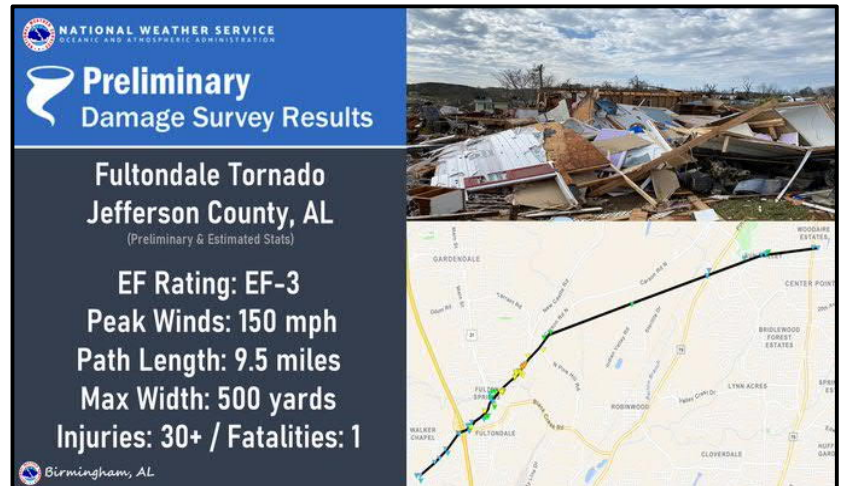

Tornado Activity

Alabama

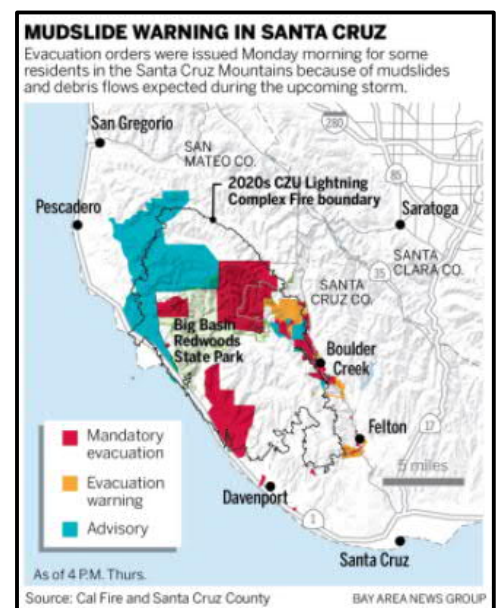
- A terrifying nighttime tornado touched down in the Fultondale and Center Point areas of Jefferson County, AL late Monday, killing at least one person and injuring at least 30 more.
- On Tuesday evening, the National Weather Service said the preliminary damage survey results indicate it was an EF-3 tornado damage with peak winds of 150 mph. It was 500 yards across and traveled 9.5 miles.
- Search and rescue efforts continued for hours in neighborhoods where it was difficult to tell where houses had stood. Across the wrecked landscape, every visible structure was damaged or destroyed.
- Fultondale suffered the brunt of the damage, but a residential area in Center Point to the northeast was also hit, the mayor of that city said.
- Gov. Kay Ivey is scheduled on Wednesday morning to tour the widespread damage from Monday night's tornado.



Mudslide Risk

California

- Residents in parts of two California counties are under evacuation orders due to a threat of potentially deadly mudslides in areas previously burned by a massive wildfire.
- The evacuations apply to several communities in San Mateo County that were previously under a warning and parts of Santa Cruz county.
- Much of the region is expected to receive between 2 and 5 inches of rain, but higher elevations could receive up to a foot, weather.com meteorologist Jonathan Belles said.
- The rain is expected to be ushered in Wednesday as an atmospheric river migrates southward through the Bay Area toward Southern California. The atmospheric river will also drive snow that is part of Winter Storm Orlena.
- The rain could cause fast-moving, deadly debris flows, informally known as mudslides; areas with wildfire burn scars are more susceptible.
