

Severe Weather Activity

Missouri


- A powerful EF-3 tornado tore through parts of Southeast Missouri on Friday, May 16.
- St. Louis Mayor Cara Spencer said more than 5,000 buildings were damaged or destroyed by the tornado.
- Seven people died in Missouri, after two additional deaths were reported in the Bootheel in Scott County.
- On May 19, Governor Mike Kehoe requested that FEMA participate in joint Preliminary Damage Assessments (PDA) of damage to homes and personal property in the City of St. Louis and St. Louis County along with Cape Girardeau, Iron, New Madrid, Scott, Stoddard, and Wayne counties in southeast Missouri, in preparation for a request by the Governor for a federal Major Disaster Declaration for these areas.
- Beginning Wednesday, May 21, six teams will survey and verify documented damage in Cape Girardeau, Iron, New Madrid, St. Louis, Scott, Stoddard, and Wayne counties and the City of St. Louis to determine if Individual Assistance can be requested through FEMA.



Disaster Declaration Request

Kentucky

- On May 20, Gov. Andy Beshear requested an expedited major disaster declaration due to severe storms, tornadoes, straight-line winds, landslides, and flooding that began May 16, 2025. Requesting individual assistance for the following eight counties: Caldwell, Christian, Laurel, Pulaski, Todd, Trigg and Union.
- This event produced significant rainfall, widespread deadly tornadic activity, hurricane-force winds, and large damaging hail.
- On May 16, Gov. Andy Beshear declared a state of emergency ahead of dangerous weather system.
- There have been 19 fatalities and 96 injuries.
- Joint preliminary damage assessments have begun in the most significantly impacted counties. Aerial photography compared with pre-disaster photos indicates the likelihood that over 1,500 homes have been either destroyed or received major damage.
