

Expedited Declaration Request

<u>Tennessee</u>

- Tornadoes and severe weather impacted Tennessee on Saturday, December 9, 2023.
- The National Weather Service has confirmed seven tornadoes. In addition to the EF-3 in Montgomery County and EF-1 in Gibson/Weakley counties that were reported yesterday, Dec. 11, an EF-2 in Robertson County (Springfield), an EF-2 in Dickson/Cheatham counties (White Bluff), an EF-2 in Dickson County (Cumberland Furnace), and an EF-1 in Stewart/Montgomery counties.
- The tornadoes killed at least six people and injured 65 others, including 62 from the Clarksville tornado.
- Montgomery County Emergency Management Agency officials have updated totals on damage from the Clarksville tornado, and it now stands at 243 "residential sites" destroyed. Another 1,711 had damage. In all, 1,974 residential sites, 58 commercial sites and three public facilities were hit by the tornado, the EMA said.
- Officials in Dickson County reported that initial assessments Sunday afternoon showed 53 homes damaged by the storm, with 7 being completely destroyed, 13 sustaining major damage and 25 with minor damage.
- Hendersonville Mayor Jamie Clary has declared a state of emergency to help secure expedited state and federal funding. There are about 10-20 homes with significant damage in Henderson-ville (Sumner County), while there are around 60-100 homes with damage, Clary said.
- Nashville Mayor Freddie O'Connell said a total of 22 structures collapsed during the storm with "countless others" damaged.
- As of Wednesday morning, Poweroutage.us showed around 3,000 customers still without power in Tennessee, some of which are not likely to be restored soon.
- On December 12, 2023, Governor of Tennessee requested an expedited major disaster declaration. He is requested individual assistance for the counties of Davidson, Dickson, Montgomery and Sumner.
