Severe Weather Outlook Midwest

- Severe weather will once again threaten areas of the Midwest on Tuesday as millions of people from Kansas City through Chicago could see thunderstorms capable of producing large hail, damaging wind gusts and even some tornadoes.
- A line of severe thunderstorms rolled across parts of Lower Michigan early Tuesday morning.
- Wind gusts to 70 mph were reported in Muskegon as the storms blew through just after 6 a.m. ET. In the wake of the powerful storms, more than 145,000 people were without power in the state, according to PowerOutage.us.
- Muskegon County Emergency Services reported that first responders were busy responding to calls regarding multiple car accidents, fallen trees, downed power lines and impassable roads.
- The main threats include scattered damaging wind gusts of up to 70 mph and isolated large hail events of up to 1.5 inches in diameter.
- Large hail, damaging wind gusts and even the risk of tornadoes will be possible from central Nebraska through western Ohio.
- The SPC said northern and eastern Nebraska and western and central Iowa could see very large hail greater than 2 inches.



Flooding Upper Midwest

- Flooding on the Blue Earth River breached the Rapidan Dam Monday morning and it's now in an "imminent failure condition," officials said.
- Le Sueur County residents in low-lying areas of the Minnesota River Valley are advised to closely monitor the situation and potentially evacuate, according to the county's emergency management office. The agency initially said the dam had failed, but later updated that the dam had been breached.
- The National Weather Service has issued a flash flood warning for areas downstream until 10:30 a.m. Tuesday.
- The Blue Earth County Sheriff's Office says debris started accumulating on Sunday at the 114-year-old dam, located about 10 miles southwest of Mankato, placing it "in imminent failure condition."
- Monday afternoon, county officials announced there had been a partial failure on the west abutment. The dam is still intact and there are no plans for mass evacuation.

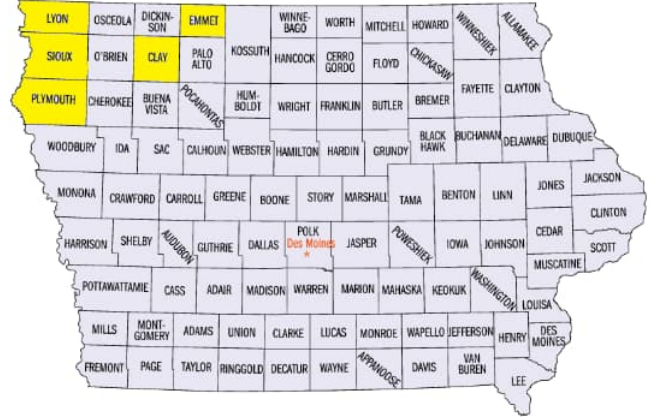

Declaration Activity

DR-4796 Iowa

- On June 24, President Joseph R. Biden, Jr. declared that a major disaster exists in the State of Iowa and ordered Federal aid to supplement State, tribal, and local recovery efforts in the areas affected by severe storms, flooding, straight-line winds, and tornadoes beginning on June 16, 2024, and continuing.
- The President's action makes Federal funding available to affected individuals in the counties of Clay, Emmet, Lyon, Plymouth, and Sioux.
- Damage assessments are continuing in other areas, and more counties and additional forms of assistance may be designated after the assessments are fully completed.
