### Tropical Activity Atlantic – Disturbance 1

- Located several hundred miles ESE of the Windward Islands.
- Environmental conditions may be conducive for slow development over the next several days.
- Formation chance through 48 hours Low (near 0%); through 5 days Low (20%).

#### Atlantic – Disturbance 2


- A tropical wave is forecast to move off the west coast of Africa the next couple of days.
- Some slow development possible by late this week.
- Formation chance through 48 hours Low (near 0%); through 5 days Low (20%).

## Severe Weather & Flood Activity

#### <u>Texas</u>

- Residents across North Texas are still surveying the damage, hoping and praying for relief soon after a historic rainstorm flooded the region, leaving behind boxes and piles of books soiled and businesses closed for cleanup.
- The Fort Worth Fire Department received 500 calls for service and performed 174 high water rescues and investigations, the department tweeted. Dallas Fire Rescue responded to 195 high water incidents and rescued 21 people and 10 dogs, the agency said in a tweet.
- As for where the water still stands, areas around the Trinity River remained under a flood warning until Wednesday afternoon, according to the National Weather Service. About 2 p.m. Tuesday, the river measured at 38 feet — above the 30-foot indicator of minor flooding, according to weather service data. Levels of 40 feet cause major flooding, and levees would be breached at 62 feet.
- Texas Gov. Greg Abbott signaled for help from FEMA Tuesday, declaring 23 counties in the Dallas-Fort Worth area "disaster areas" after more than nine inches of rain drenched the region in six hours, causing deadly and dangerous flash flooding on Monday.
- The following counties are included in the Governor's disaster declaration, with additional counties added as needed: Camp, Culberson, Dallas, Duval, Ellis, El Paso, Henderson, Hopkins, Hudspeth, Kaufman, Kerr, Live Oak, Marion, Montague, Navarro, Pecos, Rains, Smith, Tarrant, Upshur, Van Zandt, Webb, and Wood.
- At least 100 homes were damaged, and officials believe the recent flooding affected a large number of low-income families who may not have flood insurance.
- Abbott said the goal is to share the data with FEMA later this week so they can start assessing if federal funding can be provided for repairs.
