

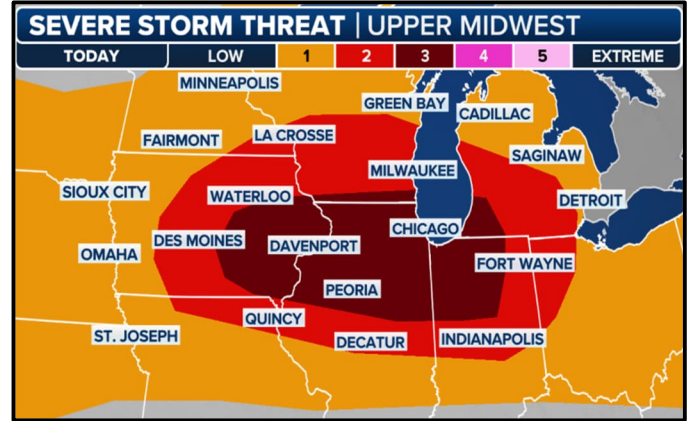

Severe Weather Outlook

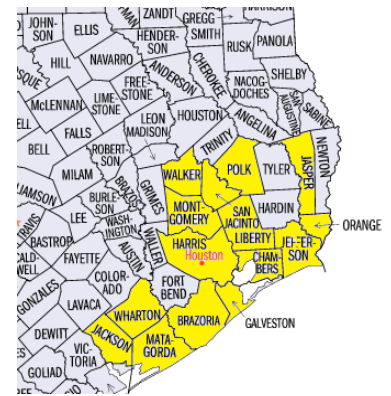
- Tens of millions of people across the Midwest face the risk of severe weather for the third-straight day, with cities such as Chicago and Milwaukee bracing for thunderstorms that will be capable of producing large hail, hurricane-force wind gusts and possible tornadoes.
- The threat comes after a destructive weekend for storms from the Plains to the Upper Midwest, with numerous reports of severe weather including a tornado spinning across a field in Barney, North Dakota, wind gusts as high as a Category 2 hurricane in South Dakota, softball-sized hail in Montana and major damage to buildings south of Chicago.
- NOAA's Storm Prediction Center (SPC) has placed more than 13 million people from Iowa to Indiana in a Level 3 out of 5 risk on its 5-point severe thunderstorm risk scale.



Declaration Activity

DR 4798 – Texas

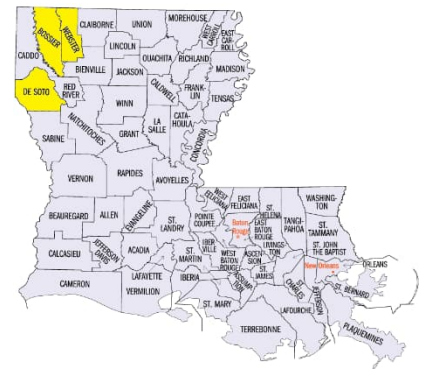
- On July 12th, President Biden amended the Major Disaster Declaration for Texas on July 12 authorizing additional federal assistance to disaster survivors to help aid in their recovery from Hurricane Beryl which occurred July 5-9, 2024.
- The President's action makes federal funding available to affected individuals in Brazoria, Chambers, Galveston, Harris, Jackson, Jasper, Jefferson, Liberty, Matagorda, Montgomery, Orange, Polk, San Jacinto, Walker, and Wharton counties.
- The state also requested Fort Bend and Nacogdoches counties be added to the individual assistance program, and other counties may be added later.



Disaster Declaration Request

Louisiana

- On July 11, 2024, Governor Jeff Landry requested a major disaster declaration for tornadoes associated with Hurricane Beryl.
- He is requesting Individual Assistance for the parishes of De Soto, Bossier and Webster.
- Beryl, which struck the Texas coast the morning of July 8th as a Category 1 hurricane, brought extreme weather to northwestern Louisiana later in the day.

- Officials reported one death, major damage to homes and businesses and significant power outages.
- On July 9, at 10:37 p.m., the National Weather Service in Shreveport (NWS) reported that five tornadoes had been confirmed during tropical storm Beryl during the afternoon and evening hours of July 8th.
