### Severe Weather Outlook

- A springlike setup is in place across parts of the nation's midsection with unseasonably warm and moist air clashing with incoming colder air, AccuWeather forecasters say.
- This battle between warm and frigid air will produce a volatile round of severe weather that could result in a significant tornado threat through Thursday.
- This severe weather is unfolding on the warmer edge of a robust storm system that is expected to impact much of the eastern half of the United States through the end of the week with flooding rain, heavy snow and powerful winds.
- "Winds high in the atmosphere are expected to be transported to the surface, and there will be a risk of tornadoes from the Texas-Louisiana border to Alabama," said AccuWeather Meteorologist Jessica Storm.
- Powerful winds could gust to 80 mph with an AccuWeather Local StormMax<sup>™</sup> of 90 mph anywhere from eastern Texas through eastern Kentucky and Tennessee. In addition, there will be a tornado threat with the strongest of the storms.



## Severe Ice Storm & Flood Activity

#### <u>Tennessee</u>

- Tennessee experienced dual weather hazards on Feb. 3, and Feb. 4, 2022, as heavy rainfall in West and Middle Tennessee turned to freezing rain and ice accumulations.
- The ice storm claimed one life in Haywood County, disrupted travel, downed trees and powerlines, and cut off power for tens of thousands of Tennesseans.
- Gov. Lee asked FEMA to work with TEMA on a joint Preliminary Damage Assessment to determine the state's eligibility for federal assistance.
- Memphis Mayor Jim Strickland declared a State of Emergency for the city on Thursday, Feb. 3.
- The following day, Shelby County Mayor Lee Harris declared a Local State of Emergency and requested that the State of Tennessee do the same.
