
# WSP USA INSPECTION SERVICES DISASTER AWARENESS REPORT

April 27, 2021

## Wildfire Activity

#### New Mexico

- The Three Rivers Fire, detected Monday morning on the backside of the White Mountains in Southern New Mexico, had grown from 30 acres to more than 4,000 by late Monday afternoon, KOAT-TV reported, and was expected to continue spreading.
- The latest size estimate is 6,100 acres. Approximately 480 homes are threatened.
- The fire is being driven by steep terrain and extreme fire weather conditions, including gusty winds and low humidity levels around 8 percent.
- There has been no containment of the blaze, which is burning about 60 miles northeast of White Sand National Park and about three hours south of Albuquerque.



 Mandatory evacuations are ordered for the areas of Nogal Canyon, Bonito Canyon, Ski Apache, Tanbark Canyon, Church Street, Ranchman's Camp, Loma Grande, Forest Road 127A-1834 Gate, Cora Dutton, and Magado Creek.

## **Declaration Activity**

#### <u>Alabama</u>

- Alabama Gov. Ivey announced Monday that certain counties in in the state have been approved for individual assistance from FEMA for the March 25-26 tornado event.
- Counties qualifying include Bibb, Calhoun, Clay, Hale, Jefferson, Perry, Randolph and Shelby.
- The National Weather Service confirmed 10 tornadoes in Alabama from the March 25th outbreak.
- Seven of those were rated at least EF-2, which qualifies them as being "strong."
- The massive Sawyerville-Centreville-Columbiana EF-3 tornado was not only very strong with maximum winds of 150 mph, but it was on the ground for over 80 miles during a 98-minute span and was upwards of 2,300 yards wide. It impacted 5 different counties (Hale, Perry, Bibb, Chilton, and Shelby).



• The Ohatchee-Wellington tornado was the deadly EF-3 with maximum winds of 140 mph. It was on the ground for more than 38 miles and was upwards of 1,700 yards wide. It killed 5 and injured an additional 10.
