

## Tropical Activity <u>Atlantic – Disturbance 1 (AL94)</u>

- Tropical development in the Atlantic is looking less likely as a cluster of thunderstorms east of the Lesser Antilles continue to march westward, however, the likelihood of this area becoming the next tropical depression or storm is unlikely.
- The disorganized tropical wave is located well over 500 miles east of Barbados, in the Atlantic.
- It has winds of up to 40 mph in a small area of thunderstorms near the wave axis.



- Conditions are marginally favorable for further development during the next few days as this wave moves westward at 10 mph. However, beyond that timeframe, the thunderstorms will enter into a region less conducive for development.
- The tropical wave will reach the Caribbean around Thursday.
- By the time it nears the Caribbean, wind shear is expected to increase, making it more difficult to produce dangerous conditions and intensify.
- However, several inches of rain are likely on the islands that this disturbance passes over. An increase in swells and rip current potential are expected late week near the Lesser Antilles.
- Formation chance 48-hours: Low (20%); 7-days: Low (20%)
