

Wildfire Activity

North Carolina


- The Black Cove Complex burning Thursday in western North Carolina is now the "highest priority fire in the U.S," the state Forest Service said.
- Currently, the Black Cove Complex Fire has burned 6,482 acres and is 11% contained.



- 476 personnel from North Carolina and other states across the nation are supporting this incident.
- Officials have evacuated residents from over 250 homes in the northwestern reaches of Polk County.
- The National Weather Service issued a Red Flag Warning for the mountains of Polk and Henderson counties, indicating the potential for severe fire behavior and the possibility of rapid fire spread.
- Governor Josh Stein declared another State of Emergency for western North Carolina Wednesday.

South Carolina

- The fires at the Table Rock State Park in Pickens County and Persimmon Ridge in northern Greenville County have been burning for six days.
- According to the South Carolina Forestry Commission, a new round of evacuations and rapid expansion of both wildfires occurred on Wednesday for the second straight day.
- The Table Rock Fire nearly doubled in size Wednesday, measuring 4,556 acres.
- The Persimmon Ridge Fire grew to 1,553 acres Wednesday.



- Wind gusts dramatically increased fire activity, resulting in greater visible fire intensity and much more smoke, according to a press release from the South Carolina Forestry Commission.
- Hurricane Helene's abundant downed timber remains dry due to the lack of significant rain, contributing significantly to extreme fire behavior on Wednesday.
- Greenville County Emergency Management Division issued mandatory evacuations for over 50 communities along the Pickens and Greenville County borders Wednesday night.
