

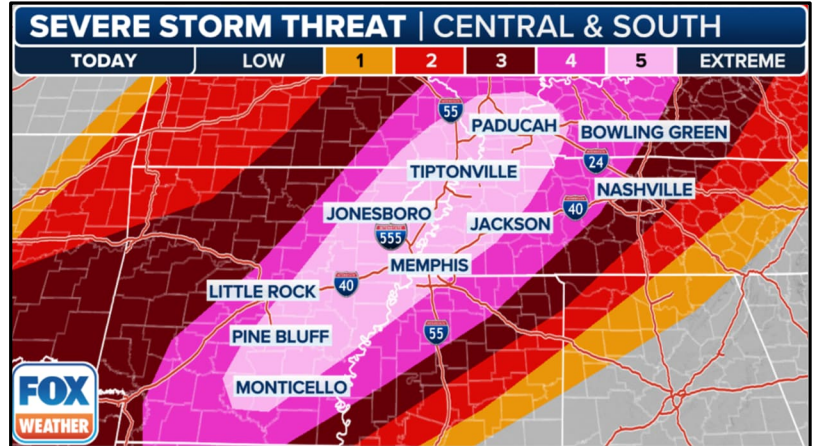

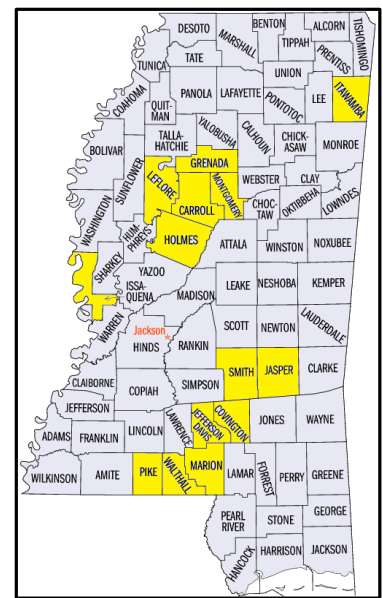
Severe Weather Outlook Central & South U.S.

- A tornado outbreak is expected Wednesday and Wednesday night from parts of the mid-Mississippi and lower Ohio valleys westward into the eastern Ozarks.
- Outside the high-risk zone, Wednesday's overall threat of severe storms spans an area from North Texas to the southern Great Lakes and also includes the potential for hail larger than 2 inches in diameter and damaging wind gusts in excess of 70 mph.
- On Wednesday morning, a line of thunderstorms exploded across central and eastern Kansas.
- By Wednesday afternoon and evening, the wider severe weather threat encompasses major cities such as Chicago, Indianapolis and Columbus, Ohio.
- While tornadoes are possible in those metro areas, large hail and damaging wind gusts are the more likely threats there.
- The SPC warned Wednesday morning that the "most intense tornadic supercells will be capable of producing long-track EF-3+ tornadoes."
- This threat is greatest from parts of the mid-Mississippi and lower Ohio valleys westward into the eastern Ozarks.
- Many of the same areas at risk of the worst of the severe weather also face the risk of life-threatening flash flooding starting Wednesday.



Disaster Declaration Request Mississippi

- Mississippi Governor Tate Reeves is requesting FEMA assistance after severe storms spawned 18 tornadoes and killed seven people across Mississippi.
- Multiple counties experienced flooding, straight-line winds and tornadoes on March 14-15.
- The state is requesting individual assistance for 14 counties: Carroll, Covington, Grenada, Holmes, Issaquena, Itawamba, Jasper, Jefferson Davis, Leflore, Marion, Montgomery, Pike, Smith and Walthall.
- According to FEMA, 233 homes were destroyed, 208 homes received major damage, 230 had minor damage and 92 homes were affected.
