June 5, 2025

Potential Flooding Activity Southeast U.S.

- A non-tropical area of low pressure is bringing heavy rain and possible flash flooding to the Southeast coast.
- The National Hurricane Center (NHC) had previously been monitoring a system for potential tropical development, but on Wednesday forecasters determined that there was no longer a chance that it would take on tropical characteristics.
- The area of low pressure started to move up the Southeast coast after dumping more than 6 inches of rain in South Florida.
- "It is becoming increasingly likely that this development will occur inland over South Carolina and North Carolina," the NHC said on Wednesday.
- Between 2-3 inches of rain is expected in the Charleston, South Carolina, and Wilmington, North Carolina, metro areas through Friday.
- NOAA's Weather Prediction Center issued a flash flood threat for portions of South Carolina and North Carolina on Thursday.
- Cities include Charleston and Myrtle Beach in South Carolina, and Wilmington, Fayetteville, Raleigh and Hatteras in North Carolina.
