### Severe Weather Outlook <u>Central & South U.S.</u>

- For the third-consecutive weekend, the Central U.S. will face a multiday severe weather threat starting Saturday night.
- More than 133 million are at risk of large hail, damaging winds and potentially a few tornadoes.

- By Saturday evening, scattered severe thunderstorms will form in northern Oklahoma into the Lower Missouri Valley.
- The much larger and more significant threat will take shape on Sunday afternoon, spanning thousands of miles across the mid-South, Lower Mississippi, Ohio, and Tennessee valleys.
- The main threats on Saturday appear to be hail in Texas and straight-line wind damage for Oklahoma and Kansas.
- The areas under the threat of severe weather Sunday will also be faced with a risk of flash flooding.
- The storm system will head to the mid-Atlantic and Southeast Atlantic coastline by Monday.

### Flooding Activity

<u>Texas</u>

- Devastating flooding hit the Rio Grande Valley on Thursday after repeated rounds of thunderstorms, dumping as much as a foot of rain in less than 48 hours.
- McAllen, Texas, took the worst of it, picking up 7.93 inches.
- Texas Gov. Greg Abbott directed the Texas Division of Emergency Management to activate state



emergency response resources ahead of increased threats of severe weather and flash flooding in large areas of the state through the weekend.

- In Brownsville, they shattered their record for the wettest March Day on record, picking up 5.70 inches.
- In total, the rain prompted the issuance of four Flash Flood Emergencies across Hidalgo and Cameron counties.
- The FOX Forecast Center said the flooding was caused by a combination of an upper-level disturbance situated over northern Mexico and record atmospheric moisture for late March.

### Severe Weather Activity Mississippi (March 14-15)

- The National Weather Service has confirmed that 18 tornadoes touched down on March 14 and 15 in Mississippi, including one EF-4, one EF-3, seven EF-2, seven EF-1, and two EF-0 tornadoes.
- To date, MEMA has recorded damage to 941 homes, 38 businesses, and 25 farms across the state. Of the homes affected, 164 were destroyed, while 204 sustained major damage.


