## Severe Weather Outlook

#### South/Southeast

- The highest chance of severe storms is expected to spread throughout Mississippi and Alabama over the coming hours.
- As daylight breaks, forecasters will be monitoring for the redevelopment of thunderstorms over communities in Georgia, Florida, South Carolina and North Carolina.
- Cities such as Atlanta; Tallahassee, Florida; Columbia, South Carolina; and Raleigh, North Carolina are all included in the severe weather risk zone.



• The severe weather is expected to push off the East Coast by sunrise Saturday morning.

### Winter Weather Activity Plains & Midwest

- The National Weather Service has placed millions of Americans from the Plains to the Midwest and Great Lakes region under winter weather alerts as the storm picks up steam and takes aim at the region.
- Within the Blizzard Warning zone, lifethreatening conditions are expected with wind gusts to 45 mph and visibilities to less than a quarter mile.

- Conditions are expected to start deteriorating on Friday morning with the worst of the weather on Friday afternoon for communities west of the Mississippi River.
- Snowfall totals between 5 and 8 inches are forecast for cities like Chicago and Des Moines, Iowa.
- According to the FAA, there is a ground stop at Chicago O'Hare International Airport due to ongoing snow, with no arrival runways available at ORD.
