

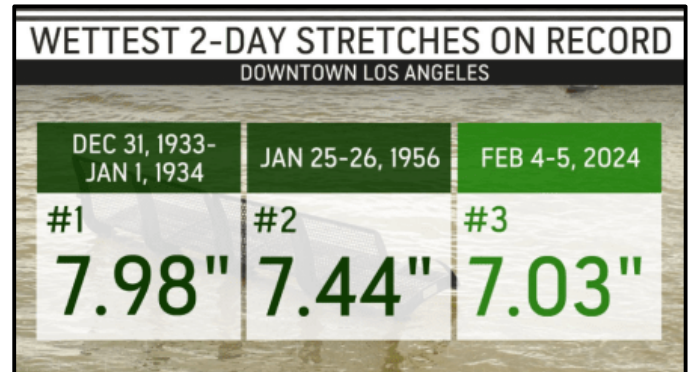

WSP USA INSPECTION SERVICES DISASTER AWARENESS REPORT

February 7, 2024

Flood Activity California

- Southern California communities are cleaning up and digging out after a multiday atmospheric river storm flooded streets, knocked down trees and took out power throughout the region.
- In the city of Los Angeles alone, crews responded to some 475 mudslide reports, in addition to at least 390 fallen trees, officials said Tuesday afternoon.
- Most of Southern California remained under flood watches, and the weather service warned people to remain on high alert, as swollen and fast-moving creeks and rivers increase the risks of drowning and the need for swift-water rescues.
- Current mandatory evacuations:
 - Los Angeles: 399
 - San Bernardino: 551
- Three shelters open with 86 occupants.
- Some 69,000 homes and businesses were still without power as of this morning, according to the PowerOutage.us website.
- The latest FEMA data shows only about 191,000 properties in the state are covered by FEMA flood insurance policies. That's only about 1.52%.
- For all LA County, the most populous in the country with 10 million people, there are only 14,580 policies.
- As of late Tuesday night, showers were continuing in many locations from San Diego to Bakersfield, and with a moist, onshore flow expected through that time, rain showers are expected to persist through midweek.
- An additional disturbance is expected to arrive Wednesday night. Any additional rain could aggravate flooding conditions, but dry weather is likely by Friday as high pressure builds offshore.



Disaster Update DR-4749 Illinois

- Cook County homeowners and renters who were affected by the Sept. 17-18 severe storms and flooding have just three days left to apply for FEMA assistance. The deadline to apply is Friday, Feb. 9 by 11:59 p.m.
- More than \$45 million has already been approved to help survivors recover.
- Friday, Feb. 9 is also the last day to visit a Disaster Recovery Center. All centers will close permanently at 5 p.m.
