Declaration Request

Kentucky

 On February 4th, the governor of Kentucky requested a major disaster declaration for the severe storms, straight-line winds, tornadoes, flooding, landslides and mudslides that occurred December 31st through January 2nd. He is requesting IA for three counties (Christian, Taylor & Pike).



- Kentucky Gov. Andy Beshear declared a State of Emergency Saturday, January 1st, after severe weather moved through parts of eastern and western Kentucky, ushering in a turbulent New Year's Day for many communities.
- Hopkinsville in Christian County suffered damage after an EF-2 tornado with 115-mile-per-hour winds hit the area, according to the National Weather Service in Paducah. The tornado was about 125 yards wide.
- The Christian County Emergency Management Agency confirmed 85 homes, 13 buildings and two churches sustained damage from the confirmed EF-2 tornado.
- Taylor County suffered EF-1 damage with winds reaching maximum speeds between 105 and 110 miles per hour. The EF-1 tornado swept through a neighborhood about two miles north of Campbellsville the afternoon of January 1st. It damaged 10 homes and 40-50 other buildings.
- The 48-hour period of storms and torrential rains in Eastern Kentucky flooded streams, creeks, and rivers, causing millions in damage to homes, buildings and roadways, was part of a statewide spate of extreme weather.
- In Pike County, early in the morning on January 1, the normally 25-foot-wide, shin-deep stream rose to nearly 30 feet in a matter of minutes, bringing with it heavy debris that further choked the narrow creek bed.
- On Jan. 3rd, Emergency management officials were working to survey the areas impacted, expecting more than 100 homes have seen damage in the Sidney, Belfry, and Johns Creek areas of the county.
- Officials say countywide, they conducted 53 rescues when the flooding happened.
