Severe Weather Outlook

- The threat of severe thunderstorms will accompany a low-pressure system as it pushes east across the Midwest and South Wednesday and Thursday.
- This next round comes just a couple of days after another strong system brought widespread damaging winds to portions of the same regions.
- The greatest threat for severe thunderstorms will stretch from southern Missouri and northern Arkansas eastward to middle Tennessee, northern Alabama and western Kentucky.



• Damaging straight-line winds are the greatest concern, but isolated tornadoes may also develop. Locally heavy rain could also result in flash flooding. The storms could occur in multiple rounds for some locations.

Wildfire Activity

<u>Hawaii</u>

- Evacuations are underway across Hawaii's Big Island and Maui as passing Hurricane Dora helps fuel wildfires that have damaged structures, prompted rescues and spurred people to jump into the ocean to escape danger, officials said.
- In Maui County, 12 people were rescued near Lahaina after "entering the ocean due to smoke and fire conditions," the Coast Guard and county officials said.



- One of the larger fires burning on the northern part of the Big Island engulfed and destroyed more than 1,800 acres. Hawaii's acting governor issued an Emergency Proclamation promising resources to hard-hit Maui and Hawai'i counties.
- Dora, a powerful Category 4 hurricane with sustained winds of 130 mph, was about 740 miles southwest of Honolulu as of late Tuesday (5 a.m. ET Wednesday), the National Hurricane Center said.
- Two brushfires were burning Tuesday on the Big Island, officials said in a news release, one in the North Kohala District and the other in the South Kohala District. Some residents were under mandatory evacuation orders as power outages were impacting communications, the release said.
- Nearly 15,000 customers were without power Wednesday throughout the state.
