




Fire Activity Texas

- A fast-moving wildfire fueled by dry and unseasonably warm conditions spread in the Texas Panhandle on Tuesday afternoon, burning more than 300,000 acres, prompting evacuation orders, closing roads and enveloping much of the region in black smoke.
- The Smokehouse Creek Fire the largest of at least four wildfires scorching the northernmost region of Texas — more





- Near Amarillo, a wildfire was burning north of Pantex, a plant that disassembles nuclear weapons, officials said.
- Texas Gov. Greg Abbott (R) issued a disaster declaration Tuesday for 60 counties to "deploy all resources needed to protect our fellow Texans and their property."
- Earlier on Tuesday, authorities issued evacuation orders for Moore and Potter counties in Texas, near the Oklahoma border, as well as in parts of nearby Roberts County.
- In Oklahoma, local officials told some residents of Ellis and Roger Mills counties, near the state's western border with Texas, to leave.
- As the blaze approached the 2,200-resident town of Canadian, Hemphill County followed suit.
 - Homes destroyed: The full extent of the damage is being assessed Wednesday morning as the sun rises, but "homes have burned in almost every direction," Johnson said. The fires knocked out power and forced families to flee to shelters.
 - Massive fire: The Smokehouse Creek Fire has burned more land this week than all of the state's 2023 fires combined.
 - Evacuations ordered: Officials in Hutchinson, Hemphill, Roberts, Lipscomb and Moore counties handed down evacuation orders Tuesday as wildfires raged.
 - Disaster declaration issued: Texas Gov. Greg Abbott issued a disaster declaration for 60 counties in response to wildfire activity Tuesday.
