## Declaration Activity

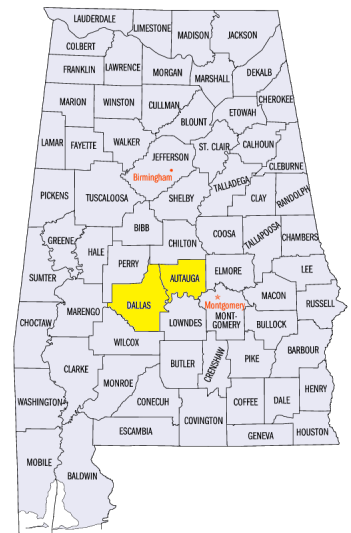
### DR-4683 California

- Several additional Pacific storm systems are forecast to impact California this weekend bringing heavy lower elevation rain and strong winds.
- Flood Warnings and Wind Advisories are in effect for portions of coastal California due to sustained winds upwards of 20-30 mph and gusts of 50 mph.
- Evacuations remain in place for 5,000 people in 5 counties.
- There have been 19 confirmed storm related fatalities.
- Currently 13k customers without power statewide.
- President Joseph R. Biden, Jr. declared that a major disaster exists in the State of California and ordered Federal aid to supplement State, tribal, and local recovery efforts in the areas affected by severe winter storms, flooding, landslides, and mudslides beginning on December 27, 2022, and continuing.
- The President's action makes Federal funding available to affected individuals in the counties of Merced, Sacramento, and Santa Cruz.
- Damage assessments are continuing in other areas, and additional areas may be designated for assistance after the assessments are fully completed.



### DR-4684 Alabama

- At least nine fatalities were confirmed following a severe weather outbreak that spawned dozens of destructive tornadoes across the southern United States on Thursday.
- In Autauga County, Alabama, located just northwest of Montgomery, seven fatalities were confirmed after a tornado created widespread damage in the county, according to the Autauga County Sheriff's Office.
- Preliminary reports from the National Weather Service show the tornado in Autauga County to be at least an EF-3.
- Alabama Gov. Kay Ivey declared a state of emergency for six counties, including Autauga County, following the storms. The counties of Chambers, Coosa, Dallas, Elmore and Tallapoosa were also included in the declaration.
- 36 structures have been destroyed, 37 have major damage and 56 with minor damage.
- On January 13<sup>th</sup>, the Governor of Alabama requested a major disaster declaration due to severe storms, straight-line winds and tornadoes.
- Today, U.S. President Joe Biden approved the request to provide individual and public assistance to 2 counties (Autauga and Dallas).
- Damage assessments are continuing in other areas and additional areas may be designated for assistance after the assessments are fully completed.
