

Tropical Storm Force Winds Northeast

- More than 60 million people from New England to the mid-Atlantic states are under a Wind Advisory, including major cities along the Interstate 95 corridor from Boston to New York City and points south like Philadelphia and Washington.
- However, it's not only coastal locations that are included in the Wind Advisory. Interior areas of the Northeast are also at risk of damaging wind gusts, with



cities like Albany, Syracuse and Ithaca in New York and Scranton, State College and Chambersburg in Pennsylvania all facing the risk of high winds.

- In addition, the entire states of Maryland, Delaware, New Jersey, Connecticut, Rhode Island, Massachusetts and New Hampshire are also under the Wind Advisory.
- Millions of people from New York City to Boston, as well as in Burlington, Vermont, in northern New England, could see wind gusts as high as 60 mph.
- Elsewhere, wind gusts between 40 and 50 mph are possible in places like Erie, Pittsburgh and Harrisburg in Pennsylvania. Washington and Baltimore could also see wind gusts as high as 50 mph on Monday.

Disaster Update

DR-4757 Michigan

- The Federal Emergency Management Agency will open additional centers starting Monday in Eaton, Kent and Oakland counties to help residents in a nine-county area recover from storms, tornadoes and flooding last summer.
- Centers will now serve residents from Eaton, Ingham, Ionia, Kent, Livingston, Macomb, Monroe, Oakland and Wayne counties. Most will operate between 8 a.m. to 6:30 p.m. Monday through Saturday and will stay open through Saturday.
- President Joe Biden approved a major disaster declaration for the nine counties earlier this year, following a request from Gov. Gretchen Whitmer.
- Severe storms starting Aug. 24 struck in Lower Michigan last year, leaving hundreds of thousands of people without power, destroyed trees and overwhelmed storm water and sewer systems. Hundreds of homeowners reported flooding.
- The deadline to apply for assistance is April 8, 2024.
