

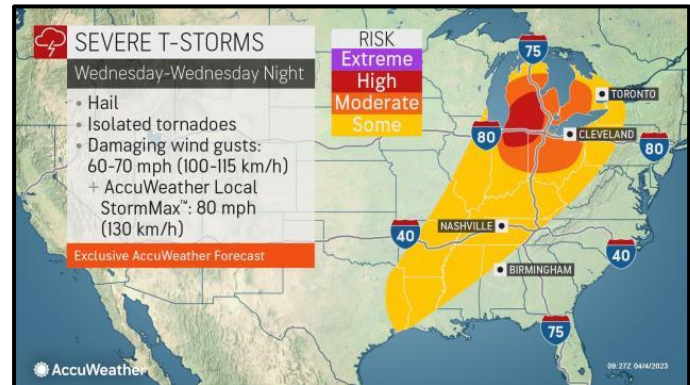

April 4, 2023

Severe Weather Outlook

- The risk of damaging straight-line winds, hail and at least a few tornadoes will continue on Wednesday, but farther to the east in the Midwest, when compared to Tuesday.
- Wednesday's threat zone will most likely include the eastern portion of the Ohio Valley to the eastern Great Lakes region and part of the central Appalachians.
- There are dozens of major cities and thousands of small towns and rural communities in the potential path of severe weather in the Heartland on Tuesday and Wednesday.
- Farther south, gusty and locally severe thunderstorms are also anticipated from Mississippi to the upper Texas coast and southern Louisiana on Wednesday.
- The greatest threat from these storms from the southern Tennessee Valley to the Gulf coast will be from large hail, isolated straight-line wind gusts and torrential downpours although isolated tornadoes cannot be ruled out either.



Declaration Activity

California

- President Joe Biden has signed the Major Disaster Declaration requested by the County of Monterey and the State of California.
- According to Monterey County Supervisor Luis Alejo, Federal Emergency Management Agency workers and assistance will now be deployed to help the community of Pajaro.
- "The people of Pajaro do so much to put food on the tables of millions of Americans, and they are now needing the support and assistance of our federal and state agencies to recover from these devastating floods," wrote Alejo on Twitter.
- The approved Presidential Major Disaster Declaration will provide eligible counties with housing assistance, food aid, counseling, medical services, and legal services. It would also provide public assistance to help state, tribal and local governments with ongoing emergency response costs and hazard mitigation to help state and local governments reduce the risks and impacts of future disasters, the governor's office reported.

- Alejo said, "We were in contact with the governor's office every day with the White House, asking when was that going to get signed? Because the help is needed desperately here in Pajaro and every day, we have residents and small businesses asking us, what is that FEMA help that arrived in our community? And we didn't have a good answer until now. We can now tell the community help is on its way."
- The counties of **Kern, Mariposa, Monterey, San Benito, Santa Cruz, Tulare** and **Tuolumne** were all named in the announcement for Individual Assistance.
